## Covid-19 Hybrid Lesson Form - One form each student (Submit once, must be submitted before hybrid lessons start)

I am choosing the hybrid plan for piano instruction at the studio. The studio is going in-person, but may need to switch to virtual back and forth depending on the current situations with Covid-19 during the school year for the health and safety of students and staff. I have read and understand the Covid-19 Hybrid Lesson Safety Protocols form.

I understand I will need to check daily for Covid-19 symptoms such as cough, fever, and sneezing, etc at home, prior to coming to the studio. I understand that if the studio scans the student and there is an elevated temperature regardless of the temperature scan at home or the student shows symptoms of illness the student will be isolated and the parent will be called to pick the student up outside, and no makeup lesson will be given. I will wait outside for two minutes after their lesson time before driving away to ensure they do not have a temperature upon entering the studio when we scan.

I understand students are not allowed to wait inside either before their lesson for more than five minutes and need to have a ride waiting for them after each lesson. Students should enter the studio no earlier than five minutes prior to their lesson. Families with back-to-back siblings or friends need to have the sibling wait in the car, to minimize waiting in the mud room area.

I understand the safety protocols the studio is providing and the parent will communicate these requirements to the student prior to coming to the studio. I understand there are risks with coming to the studio, including getting Covid-19 or other illnesses.

I understand that the Covid-19 safety protocols will take some lesson time and there could be less piano instruction time during our lesson due to the time it takes for these safety protocols. This will depend on each student's age, cooperation, and speed of the student to accomplish the safety protocols. (If you think these safety protocols will detract from lessons too much we recommend to continue doing the virtual lessons instead.)

#### COVID-19 Assumption of Risk, Release, and Waiver of Liability Agreement

RELEASE AND WAIVER. In consideration of my receiving piano lessons and all related services from PAUL NAZZARO MUSIC STUDIO (The "Services", "Service Provider"), I, being 18 years of age or older, do hereby forever release, waive, discharge, and covenant not to sue PAUL NAZZARO MUSIC STUDIO and its past, current, and future officers, directors, employees, teachers, members, volunteers, contractors, representatives, parents, owners, affiliates, agents, successors, and assigns (collectively, "Service Provider") from any and all damages, injuries, losses, liability, claims, causes of action, litigation, or demands, including but not limited to those for personal injury, sickness, or death, as well as property damages and expenses, of any nature whatsoever which may be incurred, directly or indirectly, now or in the future, in any way related to COVID-19 and in connection with my participation in the Services or any travel related thereto. I promise not to sue Service Provider for any of the foregoing.

ASSUMPTION OF RISKS. I understand that while Service Provider has undertaken reasonable steps to lessen the risk of transmission of COVID-19 in connection with the Services, Service Provider is not responsible in any manner for any risks related to COVID-19 in connection with the Services. I understand that the World Health Organization has classified the COVID-19 outbreak as a pandemic. I further understand that COVID-19 is a highly contagious and dangerous disease, and that contact with the virus that causes COVID-19 may result in significant personal injury or death. I am fully aware that participation in the Services (including any related travel) carries with it certain inherent risks related to COVID-19 transmission ("Inherent Risks") that cannot be eliminated regardless of the care taken to avoid such risks. Inherent Risks may include, but are not limited to, (1) the risk of coming into close contact with individuals or objects that may be carrying COVID-19; (2) the risk of transmitting or contracting COVID-19, directly or indirectly, to or from other individuals; and (3) injuries and complications ranging in severity from minor to catastrophic, including death, resulting directly or indirectly from COVID-19 or the treatment thereof. Further, I understand that the risks of COVID-19 are not fully understood, and that contact with, or transmission of, COVID-19 may result in risks including but not limited to loss, personal injury, sickness, death, damage, and expense, the exact nature of which are not currently ascertainable, and all of which are to be considered Inherent Risks. I hereby voluntarily accept and assume all risk of loss, personal injury, sickness, death, damage, and expense arising from such Inherent Risks. Furthermore, I represent and warrant that I do not suffer from any medical condition or disease that might in any way hinder or prevent me from receiving the Services, including, to my knowledge, COVID-19.

This COVID-19 Assumption of Risk, Release, and Waiver of Liability Agreement ("Agreement") shall be binding on my heirs, executors, administrators, successors, and assigns. I expressly agree that this Agreement is intended to be as broad and inclusive as is permitted by applicable laws, and that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. This Agreement contains the entire understanding of the parties relating to the subject matter, and shall not be altered, modified, amended, waived or supplemented in any manner whatsoever except by a written agreement signed by both parties hereto or their duly authorized representatives. This Agreement may be executed, made and delivered electronically.

To the maximum extent permitted by applicable law, I (a) covenant and agree not to elect a trial by jury with respect to any issue arising out of this Agreement or the Services that is triable of right by a jury, and (b) waive any right to trial by jury with respect to such issue to the extent that any such right exists now or in the future. This waiver of right to trial by jury is given knowingly and voluntarily.

I have read and understood this Agreement and enter into it voluntarily in consideration of the opportunity to participate in the Services. I acknowledge I am giving up legal rights and/or remedies which may be available to me.

### Covid-19 Hybrid Lesson Safety Protocols

Please talk about these with your family and child.

September 2021

- 1. <u>Covid-19 Hybrid Lesson Form</u>. Please fill out and sign before students come in for their first hybrid lesson, one form for each student, not one for the family.
- 2. <u>Release Waiver.</u> We need a release waiver signed by a parent or student over the age of 18 before the first hybrid lesson. We need one for each student, not one for the family.
- 3. Home Screening Prior to Coming to Studio. No daily health screening form submission will be required. Parents/guardians will perform their own daily health screening listed below, please keep your child home and notify the studio. Parents should check for temperature and symptoms prior to coming to the studio. If there is a fever of 100.0 F or higher or any symptom, just do the virtual lesson at home and nothing is missed. Students should not come to the music studio if they have or have had in the past 14 days a cough, sneezing, congestion or runny nose, fatigue, nausea or vomiting, a fever, chills, rigors (shivers), myalgia (muscle aches), headache, shortness of breath, difficulties breathing, flu-like symptoms, allergy-like symptoms, gastrointestinal upset, or experienced a loss of taste or smell. If a student or family member is quarantining, you must do the virtual lesson.
- 4. <u>Travel</u>. As per the travel advisory, non-essential travel while school is in session is discouraged. At this point, domestic travel does not require quarantine unless exhibiting symptoms of illness. Unvaccinated students will be required to quarantine upon return from international travel.
- 5. Entering the Studio. Students will remain in their cars until five minutes before their lesson. A maximum of five minutes of waiting in the mudroom. Only students should come in the mudroom, parents and family should please wait in the car. Parents of very young students can walk students to the studio entrance to enter safely. For regular communication with the teachers, we can use phone calls and emails for updates. When entering, students will apply hand sanitizer before removing coats and shoes, then take off their coats and shoes, and immediately wash their hands in the bathroom.
- 6. <u>Temperature</u>. The teacher will take the temperature of students immediately as they enter the music studio and be mindful using visual screening at the lessons. We will be using touchless forehead scanners. If an elevated temperature is noted regardless of what your temperature was at home, parents will be called and the students will be instructed not to enter the music studio and to proceed home. Please wait before driving away for two minutes to make sure your child does not have a fever upon entering the studio.
- 7. <u>Hand Sanitizer.</u> Hand sanitizer will be applied in the mudroom prior to taking off coats and shoes, and again in each teacher's studio after washing hands. Students must use it upon entering the studio and upon leaving the studio. Teachers must observe students applying the hand sanitizer, all ages.
- 8. <u>Hand Washing</u>. <u>Teachers must observe students washing hands for 20 seconds, regardless of age. This is something that is so essential that we cannot cut corners on and is a cornerstone of the safety of the studio. The bathroom has touchless paper towels and a foot activated closed waste paper can. Please take all other waste out of the studio with you to minimize filling the trash can and spreading germs.</u>
- 9. <u>Masks</u>. We are requiring face masks by both the student and teachers regardless of vaccination status. Face shields, gaiter necks, bandanas, and other indicated wearables described by the Westfield Public Schools (see handout) are not acceptable. The studio has a supply of disposable masks for students who forget to wear one or do not adequately protect the student or teacher. Masks must be worn over the nose at all times and fully covering under the chin. If a student is not able to keep their mask on properly, it would be recommended they do video lessons.
- 10. <u>Ventilation</u>. Studio areas will have ventilation with open windows, space heaters, and fans. Both studios have air filtration air purifiers with HEPA filters, as well as high quality air filters in the studio's heating and cooling system.
- 11. <u>Sanitation</u>. We have established a set schedule to sanitize all areas where persons have been during the time the music studio is open. Pianos will be sanitized between every student towards the end of each lesson. After each day, sanitation will include instruments, tables, chair arms, door knobs, light switches, hangers or anywhere else where people come in contact.
- 12. Pencils. Students should bring a few sharpened or mechanical pencils with good erasers at each lesson to stay in their music bag.
- 13. Social Distancing in the Studio. Teachers and students will be 3 feet away from each other.
- 14. <u>Leaving the Studio.</u> Parents should make sure they are waiting in their cars ready to pick up the student at the end time of their lesson. <u>Students cannot wait in the mud room</u> and must proceed directly outside. No students, parents, or others should be waiting outside on the premises but should wait in their cars. Younger students who do not know how to tie shoes are encouraged to wear shoes that do not need tying, or tie them outside because of how long it would take in the mudroom and not hold up other students entering after them.
